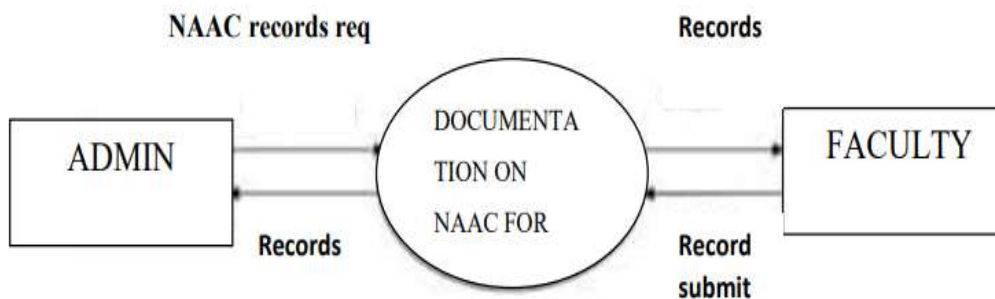


Fig 1:Flow diagram of NAAC

**Faculty:** The responsibility of the faculty is to login into the site and can able to select his/her respected criteria and upload the documents and also he can see the notifications sent by the admin.

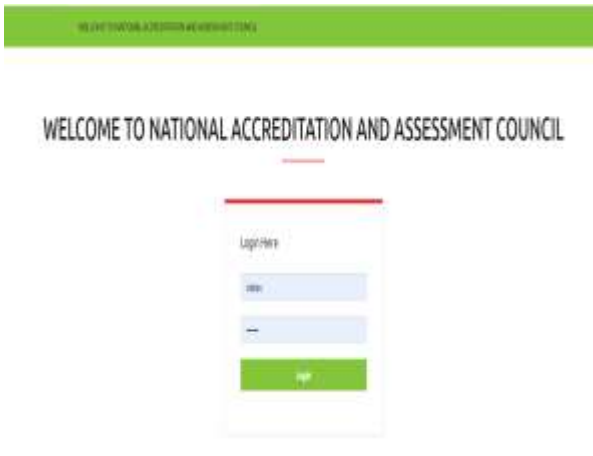


Fig 2:Admin login

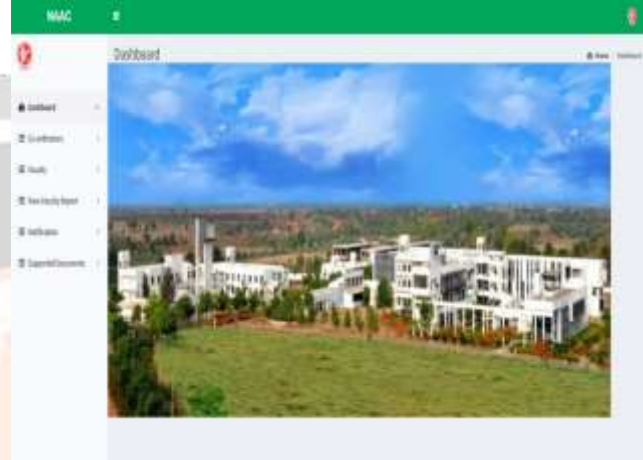


Fig 3:Admin page

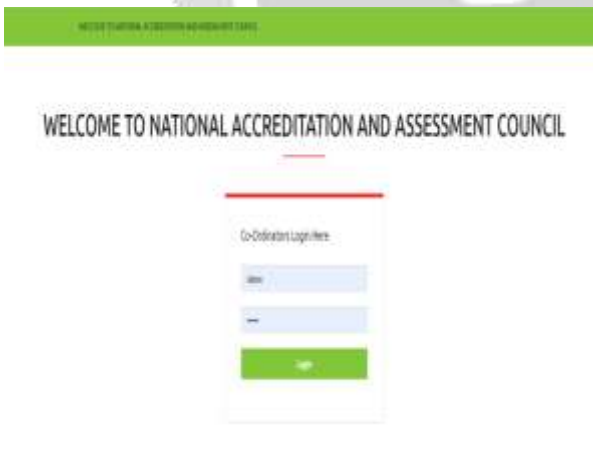


Fig 4: Coordinator login

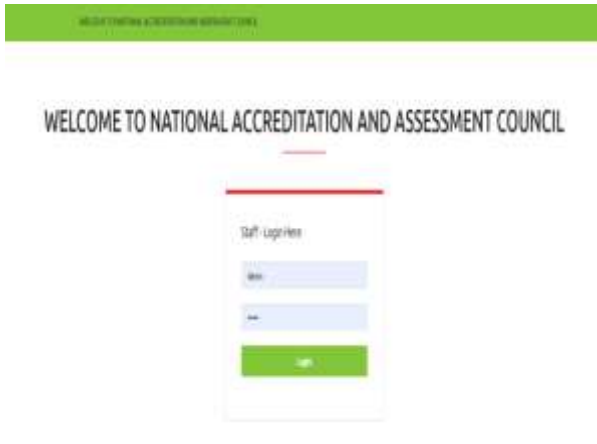


Fig 6:Faculty login
