

- C. See all medicine





Fig 3.1 Block Diagram

Medicine name, medicine Description.




C. See Stuff: Admin can view all the medicines details and assign to respective Volunteers.

The user who want to donate the things will first have to register himself on the web application and verify their phone number.


- After successful verification he can login to the website.

- Change Password: Member can change their password in case of security.







Fig 1.2 Employee Registrtion Form




Fig 1.8 List of Charity Trust Form
