2. **Primary Data:** Collected through field surveys and interviews with MSME owners, industry experts, and government officials in MP and J&K.

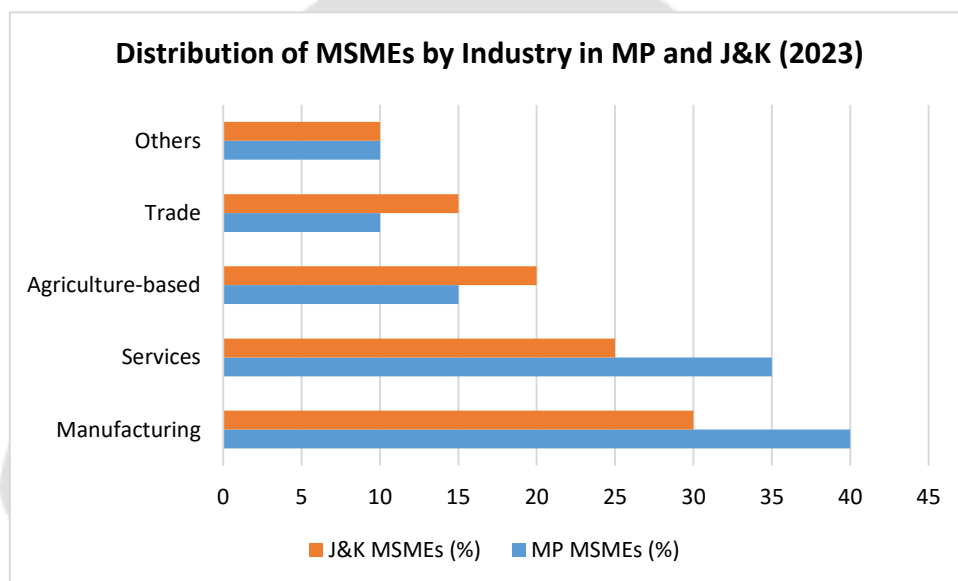
## Data Analysis

## Results

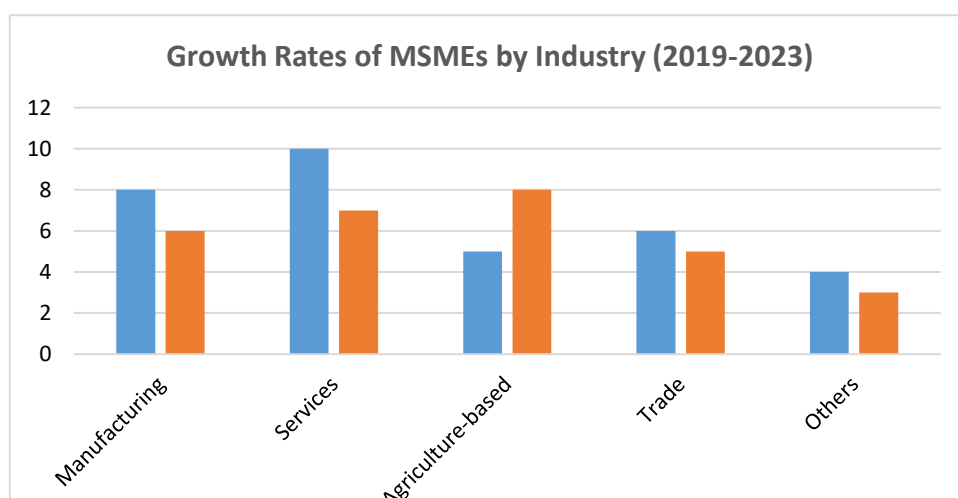
**Table 1: Distribution of MSMEs by Industry in MP and J&K (2023)**
