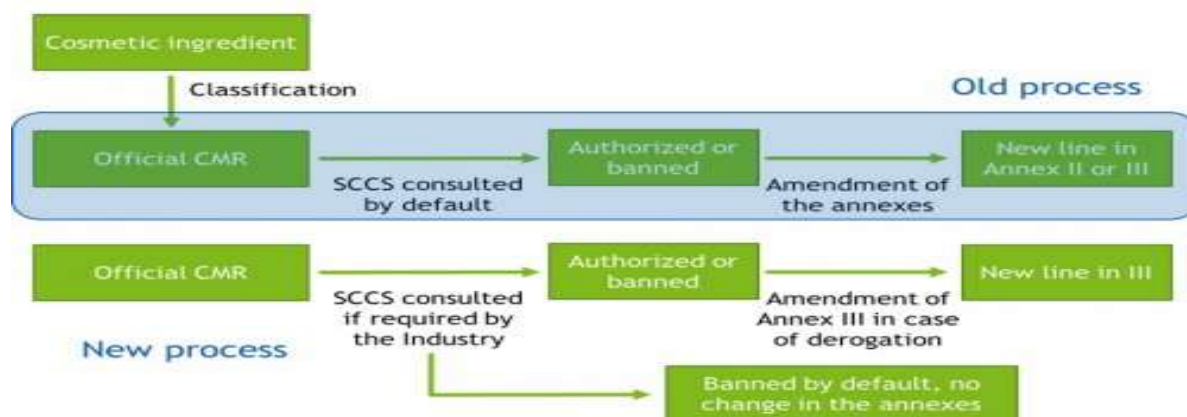
## INTRODUCTION:-

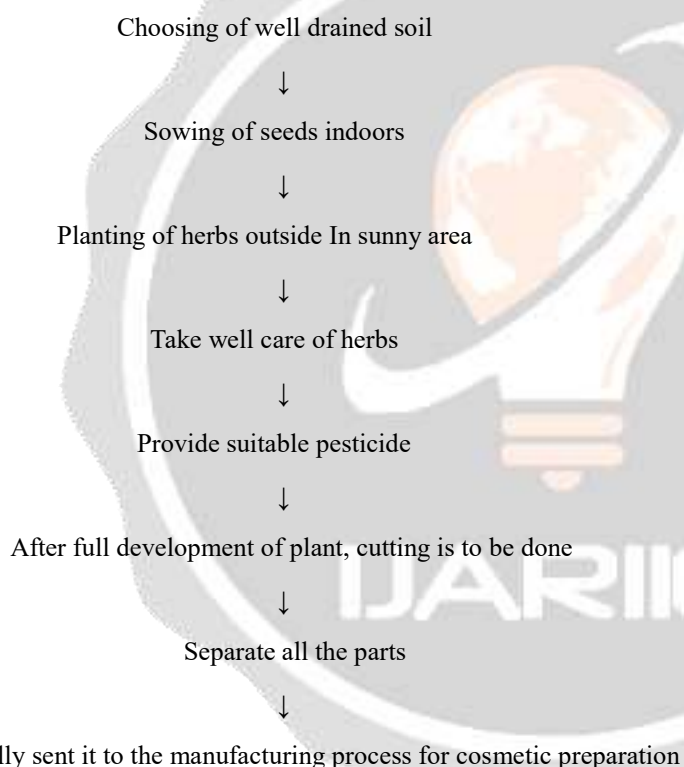
water got evaporates. keep the oil for cooling after which clear out it. on this manner oil soluble principle of herb is going into oil [20].
